23/24 -081 Meeting with Yorkshire Water Rangers Team

The litter pick on 4th November had to be cancelled due to weather conditions but the meeting with the Yorkshire Water Rangers Team, Parish Councillors and residents continued, and was very useful. Parish Council projects proposed to Yorkshire Water included a picnic area by the pond, clearing areas around bilberry bushes and a Children's trail.

Resolved: approve costs of refreshments £21.77 and to send proposals to Yorkshire Water.

The Chairman reported that he and a resident who had recently contacted our local MP, had met with Miriam Cates MP to discuss provision of super-fast broadband in the Parish. The Parish Council had been in contact with BMBC regarding broadband provision over the past year, and understand that the roll out will commence in January 2024. **Resolved:** Details will be included in the Christmas edition of the newsletter and a questionnaire produced to be delivered with the newsletter, to promote Langsett's requirement for super-fast broadband provision.
