**22/23 -025 Apologies for absence**

No apologies received.

**22/23 -026 Declarations of interest**

**22/23 -027 Exclusion of the press and public from agenda item 7 : Vacancy on the Parish Council**

**Resolved:** to exclude press and public from agenda item 7 to discuss the current vacancy on Langsett Parish Council and applications received.

**22/23 -028 To open agenda item 5 re proposals of Yorkshire Water to introduce parking charges to members of the public for receipt of comments**

**Resolved:** to open up agenda item 5 to allow discussion with members of the public

**22/23-029 Proposals of Yorkshire Water to introduce parking charges for car parks in Langsett**

The Chairman explained the proposals of Yorkshire Water to introduce parking charges for both car parks in Langsett, and opened the meeting up to allow residents to voice concerns raised by the proposal and to submit questions to be raised to Yorkshire Water in advance of their attendance at the Parish Council meeting on Monday 4<sup>th</sup> July.

Concerns raised included the impact of the displaced parking which is expected from the proposed introduction of parking charges in both car parks (with potential parking on the A616, Gilbert Hill, Old Manchester Road already experienced in the recent past), the effect on the roadside verges including increased littering, the effects on local businesses by the displaced parking, the lack of public transport which impacts vehicle usage to visit Langsett, and the safety implications of vehicles parking on smaller roads or the A616 which impact access of emergency vehicles and the safety of pedestrians walking close to traffic. A full list of questions and comments will be compiled and sent to Yorkshire Water for reply.

**22/23 - 030 Planning Applications received**

**2022/0466 Little Doubting Farm**, Hartcliff Hill Road – conversion and alterations for former barn to residential tourist accommodation

**Resolved:** The Parish Council raised concern regarding the style of the building which did not seem to be in keeping with its location and within the Green Belt. Advise of concerns to BMBC Planning dept and if a change of use would be required.

**2022/0528 2 Ivy Cottage**, Manchester Road, Langsett – installation of 15 roof mounted solar panels to garage roof
