Minutes of the Meeting of Langsett Parish Council held at The Barn, Langsett on Wednesday 20th March 2024 at 7.00pm

Present: Cllr Peter Horner (Chair), Cllr Linda Taylor, Cllr Dean Furniss, Cllr Lynn Hammond, Cllr Kate Wood, and Avril Sturdy (Clerk & RFO)

23/24 -110 Apologies for absence

There were no apologies for absence. Cllr Wood sent notice of late attendance.

23/24 -111 Declarations of interest

None received

23/24 -112 Minutes of the meeting held on 8th January 2024 Cllr Hammond advised an amendment to 23/24-099 to note "Reported dog bin at the top of Brookhouse Lane was missing, with *black /white bags* in its place" It was resolved that the minutes be approved as amended and signed by the Chairman.

- 23/24 -115 Planning Applications received since the agenda was produced None received.
- 23/24 -116 Information on previous planning applications (decisions by BMBC) Under consideration: 2023/0665 Little Doubting Farm, Langsett : Erection of menage

23/24 -117 Items to bring to the attention of BMBC Neighbourhood Services

Resolved: Report again that the dog bin at the top of Brookhouse Lane was still missing, with black/white bags in its place, which are not suitable. Request a permanent fixed dog bin.

Cllr Hammond questioned if there could be larger industrial sized bins in the laybys on the A616 and A628 rather than the smaller domestic sized bins, and that the bin in the Flouch car park also seemed too small. **Resolved**: Clerk to raise the concerns with BMBC

The old heritage bin on the A616 outside the Waggon & Horses pub has been replaced by a new bin which is out of character and not in keeping with the heritage location. There had been no consultation with the Parish Council. **Resolved:** complain to BMBC including the Heritage Officer.

23/24 -118 Roads, Transport and Parking

Following a freedom of information request, South Yorkhsire Police advised that there had been 29 incidents on Gilbert Hill in the last 5 years. It was noted that recently another car had left the road into the field. **Resolved**: contact BMBC Highways with this information with a request to investigate the issues and if a barrier on the bend in the road on Gilbert Hill could be installed.

The bushes on Fulshaw Lane by the junction require trimming. Resolved: Advise BMBC Highways

23/24 -119 Footpaths and Public Rights of Way Issues

The Clerk advised that notification had been received that the Hartcliff Hill Race was planned for 24 April.

23/24 -120 Digital Connectivity within the Parish

Cllr Horner had provided details of interest but there had been a delay in finalizing the next wave. Cllr Horner will chase prior to the next meeting and will update at the May meeting as Langsett area may be in the next wave.

23/24 -121 Defibrillator Training

The Clerk advised that 15 residents attended the defibrillator training on Monday 15th January 2024. Cllrs Hammond and Taylor were thanked for their help with the event. It was proposed to organize a regular defibrillator training session every 2 years.

Correspondence had been received from South Yorkshire Ambulence Service regarding maintenance of the defibrillator at The Old Mustard Pot, Midhopestones. **Resolved**: advise that Bradfield Parish Council would be the appropriate contact regarding the defibrillator and the Clerk would forward on the details.

23/24 -122 Trough Planting, Langsett

It was agreed to plant up the stone trough at the side of the A616 below Gilbert Hill junction by ClIrs Taylor and Horner late Spring .

Resolved: plants and compost would be purchased to a maximum of £20.

Cllr Horner had circulated to Councillors a proposed list of projects working with Yorkshire Water. **Resolved**: advise Yorkshire Water of proposed projects and invite the Ranger Team to a meeting to discuss the projects.
