The bridle way signs including on Browns Edge Lane required fresh lettering.

Locks on the Yorkshire Water gates had been replaced but it was understood that the Fire Brigade had cut one lock.

Mickledon Straddle Fell Race – planned for Sunday 1st February 2026 . **Resolved:** no issues envisaged and the Clerk to confirm with the organisers.

Mounting blocks on A616 – The Clerk had contacted National Highways regarding the installation of mounting block on the side of the A616, between Brown’s Edge Lane and Flouch car park, and in response although there was no immediate plans to put Mounting Blocks in this area, this request would be noted.
