Groups drinking and setting BBQ's on the "beach" area of the reservoir were reported. **Resolved**: Clerk to send details to the Yorkshire Water Rangers Team.

Resolved: Advise BMBC that the bridlepaths opposite Brown's Edge Lane, and running parallel with A616 were overgrown.

23/24 -035 Roads, Transport and Parking

The condition of the new road surface following roadworks on Gilbert Hill, leaving amounts of loose gravel, which may cause an issue for vehicles driving down the hill especially at the sharp bend was reported to BMBC Highways. This issue is being sent to the Surface Dressing Contractor for assessment.

The ditch on Gilbert Hill hidden from view by grass, has been sent to BMBC Highways Drainage for assessment.

South Yorkshire Police were asked how many accidents have been reported on Gilbert Hill over the past 2 years. **Resolved**: as no reply received, chase for information.

A resident raised the issue of speeding cars along Midhopecliffe Lane, and requested the introduction of speed bumps. The Parish Council would alert the Police but did not think that the introduction of speed bumps were necessary currently.

Suggestions had included a pop up café but after consideration would not go ahead as this may conflict with local businesses, a litter pick event, September newsletter.
