The litter bin in the layby at Langsett is constantly full and it was **resolved** to ask BMBC of the frequency of emptying.

**21/22-037 Update on litter pick Saturday 26<sup>th</sup> June 2021**

It was noted that the litter pick had been well organized, although not many residents attended, but a trailer full of rubbish was collected. The next litter pick could be broader and possibly held mid-September.

**21/22-038 Footpaths and Public Rights of Way Issues**

It was reported that BMBC Rights of Way team have not yet visited the site of the right of way with the broken bridge. The Clerk to chase.

The condition of overgrown vegetation affecting line of sight at the crossroads, at the top of Mossley road was noted and the Clerk to report to BMBC.

An invitation to share the use and the cost of a Speed Indicator Device had been received from Oxspring Parish Council. It was **resolved** not to participate due to the nature of the local roads but to ask Highways England if the speed indicator removed on the A616 could be replaced.

A response was still awaited from Highways England regarding guidance relating to possible street furniture e.g. planters. It was **resolved** the Clerk to investigate the possibility of training for use of the defibrillator via a public session in Langsett Barn, and associated costs.
