Minutes of the Meeting of Langsett Parish Council held at The Barn, Langsett on Wednesday 6th August 2025 at 7.00pm

25/26-024 Apologies for absence

No apologies for absence received.

25/26 -025 Declarations of interest

No declarations of interest.

25/26 -026 Presentation from Quickline broadband provision

The Chair welcomed Ms Spratling, Mr Furnass and Mr Parks of Quickline Ltd.

Resolved: the meeting was opened to members of the public to receive information from Quickline regarding the provision of broadband within the Parish.

After giving background information on Quickline, its start-up and its contract to provide broadband to rural communities under the government-initiated Project Gigabit, the stages of implementation were explained. Planning, surveying, test rodding would and have been undertaken and existing infrastructure (cables) would be used as much as possible to avoid distribution if possible.

Prior to implementation, residents can already register their interest with Quickline. Packages would be available on the Quickline website.

If residents wanted to move onto Quickline's provision, and had some contract period left with existing provider, it may be possible that Quickline may buy out the remaining contract, but this would be subject to discussion with the individual. There is no minimum number of contracts required for installation. It was anticipated that speeds would be up to 900mb and the infrastructure is due to go live in January 2026.

The Quickline presentation would be placed on the Parish Pencil website.

Gilbert Hill - awaiting confirmation from BMBC Highways regarding installation of reflective **Mounting blocks on A616** – The Clerk to contact National Highways regarding the installation of mounting block on the side of the A616, not near the car park.

Warning signs on A616 – the distance stated on the warning signs is incorrect and are not 220 yards away. **Resolved**: report to National Highways

The Chair reported that the trough on the A616 had been planted up, but felt it was not as successful. A resident has offered to maintain it going forward. **Resolved**: to accept this offer and the Chair would confirm to the resident.
